The papers in this collection comprise records generated by several progressive healthcare organisations that were particularly concerned with countering the racially-based healthcare policies of the apartheid government. There is an emphasis on the treatment of detainees. The organisations include the National Medical and Dental Association, the Emergency Services Group, South African Health and Social Services Organisation, the Unity Health Forum, the National Progressive Primary Health Care Network, the Community Health Care Trust, the Dopstop Association and the Mamre Community Health Project of the UCT Medical School. There are thematic files on various health care subjects and audio-visual media relating to a Ethics and Human Rights course for UCT medical students; proceedings of the 1995 conference of the International Committee on the Rehabilitation of Torture Victims held in Cape Town, and the proceedings of Truth and Reconciliation Commission's hearing into the health sector (1997).
